Course overview



Rail Mounted Disc Cutter (PTMP 03.01)

This course is designed to train persons who are responsible for undertaking this course as part of their duties on Network Rail Infrastructure. It is designed to develop a person's knowledge, understanding and skills, and is therefore particularly suited to persons required to prove their capability in these areas.

Instructions

It is the Sponsors responsibility to ensure candidates booked onto the course are eligible for the training they are to receive and in line with any relevant medical level or restriction that may apply, in accordance with NR/L2/OHS/00124 Competence Specific Fitness Medical Requirements

Delegates must be at least 18 years of age.

Must have sufficient command of English language, and of the English language as detailed in Network Rail Company Specification NR/L2/CTM/021 (Competence & Training in Track Safety).

Must hold a valid Sentinel Track Safety Card endorsed with valid PTS.

For NWR candidates, must have attended the PTMP 00 Safe Use of Portable & Transportable Equipment & PTMP 03.06 Cutting and Grinding Equipment courses and successfully completed the assessments.

Meet the medical requirements of Network Rail Standard NR/L2/OHS/00124 Competence Specific Fitness Medical Requirements to minimum medical level 1 and Network Rail Standard NR/L2/OHS/0120 (Drugs & Alcohol).

Please advise of any special needs i.e. dyslexia in advance of the course.

Must Bring Photo ID - For British Nationals, one of the following (original hard copy - not electronically): a current and valid branded form of identity token, used for accessing the RMI (Railway Maintained Infrastructure) such as a Sentinel Card; in-date and valid full driving licence; in-date and valid UK Provisional Photo Card Driving Licence; in-date and valid passport, a UK biometric ID Card/Residence Permit (BRP), an Armed Forces Identity Card, a proof of age card recognised under PASS with a unique reference number (this includes the Citizen ID Card), N.I. Electoral Identity Card or a resident permit as per Home Office guidance.

For Non-British Nationals - an in-date and valid passport, Identity Card or Driving Licence from an EU or European Economic Area (EEA) country or a US Passport Card is required (**original hard copy - not electronically**).

PPE – hard hat, Orange Hi-Visibility clothing to RIS-3279-TOM standard, ear defenders, goggles, Safety boots with full ankle and mid-sole protection and leather gloves and flame retardent leg protection/spats, leather apron, dust mask M3 or air flow equipment.

If training is taking place externally, a hot works permit, spill kit and fire extinguisher will needed on-site
