This qualification is relevant to every workplace, the NEBOSH National General Certificate is ideal for managers, supervisors and anybody with health and safety management responsibilities. It's also perfect for those embarking on a health and safety career and gives you a stepping stone to success.

This course provides delegates with knowledge on risk assessments and ways to control common workplace hazards such as fire, lifting and carrying, work equipment, electrical safety, hazardous substances and transport.

This qualification combines activities, learning and interactive materials to provide you with an interesting and engaging experience. It focuses on key skills that means you can instantly apply the knowledge you gain and add value to your organisation.

The two-step assessment process, which checks what you know and can do, consists of:

- An open book examination (NG1)
- A practical risk assessment (NG2)

Instructions

There are no entry requirements for this qualification, however it is important that learners have a suitable standard of English language in order to understand and articulate the concepts contained in the syllabus.

NEBOSH recommends that learners undertaking this qualification should reach a minimum standard of English equivalent to an International English Language Testing System (IELTS) score of 6.0 or higher in IELTS tests.

Delegates will need a laptop to undertake this course and links for the course will be issued two days prior to course commencement. Please contact sales@intertrain.biz if these have not been received by the day before.

Delegates must bring Photo ID – Any photo ID.

Confirmation of registration for digital assessments

Once you have been registered for your digital assessment, NEBOSH will send you a Confirmation of Registration email that includes your learner number, and important information relating to your assessment. 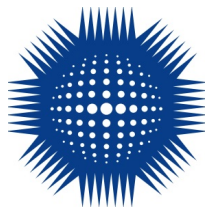
Following receipt of your Confirmation of Registration email for your digital assessment, NEBOSH will send you a further email containing your Username and Password for the NEBOSH online examination platform. If you have not received this email please remember to check your spam folders.

The two-step assessment process, which checks what you know and can do, consists of:

- An open book examination (NG1)
- A practical risk assessment (NG2)

NG2 - This is a practical assessment where learners will complete a risk assessment and develop an action plan for their workplace. Your assessment can either be hand written or completed electronically. The assessment pack contains two sets of forms; one for a hand written assessment and the other for an electronic assessment.

All results for assessments taken in English (including those for the practical application) should be received within 50 working days from the date of the examination or submission of assignment. The specific date is written on your examination entry confirmation.
